TERMS AND CONDITIONS OF ENROLLMENT

The following Terms and Conditions of Enrollment apply to all students who registered with Cavalry Italian Design School. All fees and monies when mentioned are in Singapore currency. Once signed, these terms and conditions are legally binding under the laws and jurisdiction of the Republic of Singapore.

1. ADMISSION POLICY

Admission to Cavalry Italian Design School (henceforth known as the School) is opened to all individuals regardless of sex, race, religion or nationality. Selection for admission is based on overall assessment of the individual's potential. The School reserves the right to reject an application and to potentially review a student's progress in the School. The School may, at its discretion cancel a student's registration for lack of academic progress, failure to honor fees payable or failure to abide by the Rules and Regulation outlined in the Student Handbook.

2. FEE STRUCTURE

Registration: The Registration Fee is non-refundable.

Tuition Fees: The tuition fee is due ONE MONTH before the commencement of the term

3. DEPOSITS, PAYMENTS, WITHDRAWALS, DEFERMENTS

Deposits: Upon acceptance of the student application by the School, the student is required to pay a deposit of S\$2,000. This deposit will constitute part of the First Year school fees.

Payment: Tuition fees paid are strictly non-refundable. If there are compelling circumstances that impede the student's ability to continue the studies, the student has to inform the School in writing at least 14 days before the commencement of the term

If the application of the new Student Pass is not approved by Immigration and Checkpoints Authority (ICA), the School will refund all fees paid (excluding registration fees). This is not applicable to renewal of Student Pass cases.

Withdrawal from Programme: Students wishing to withdraw from any programme will be interviewed by Student Services Manager and filed a formal "Withdrawal from Programme" application and submit the completed form to the Administration department. The School will consider each application on a case by case basis.

Deferment: Students who wish to defer their term of studies have to inform the Student Services at least 2 weeks before the commencement of the term. The decision to grant the students

deferment is at the sole discretion of the School and will be considered on a case to case basis. Students who apply for deferment will re-enroll under the tuition fees in effect at the time of their re-enrollment. Students who wish to reserve a place for their return, will have to pay an administrative fee of S\$200 for 6 months or less and \$400 for 7 months to a maximum of 12 months. The amount paid is non-refundable. To rejoin the School, the student has to inform the School in writing ONE MONTH before the term begins to indicate the intention to resume studies.

4. EXAMINATIONS AND EVALUATIONS

To qualify for a Cavalry Italian Design School / Istituto Moda Burgo award, students will be required to successfully complete various course work, examinations, projects, and other forms of evaluation deemed appropriate by the School. Various conditions apply to the eligibility for examinations. Students will only be admitted to examinations provided that the student has (1) met all current financial obligations and (2) fulfilled the requirements of the course leading to the examinations. Examinations are administered at regularly scheduled times and students must be available during examinations. Students failing to attend examination may be liable for a separate examination fee to have an equivalent examination set, administered and marked. Student assignments, projects and other school related work may be retained by School or project sponsors for a period of up to 6 months for marketing and promotion purchases.

5. CLASSES

All classes are conducted in English and students are expected to be proficient in English at a level which enable them to participate and benefit from the programme. Classes are scheduled on weekdays between 9.00am and 9.30pm and on weekends between 9.00am and 1.00pm.
